

# **Drawing Time Frame**

The contest begins on January 12, 2016 and ends at 12:00 pm (Central time) on April 30, 2016, unless terminated earlier as provided herein. Entries must be received by 12:00pm (Central time) on April 30, 2016, to be eligible for the prize drawing.

## Eligibility

- 1. No purchase or account relationship is necessary to win.
- 2. The contest is open to individuals 18 years of age or older who are legal residents of the United States at the time of entry.
